4. Approve Minutes – [12/20/17 Regular Board Meeting] – Agenda #4

Mr. Petroccelli moved the Board accept the recommendation of the Superintendent and approve the minutes of the December 20, 2017, Regular Board of Education Meeting.

5. <u>Board Committee Reports – Agenda #5</u>

Audit:

Mrs. Crowley reported that the Audit Committee has not met since the last Board meeting. The Internal auditors are scheduled to be in the District the week of February 12th to perform the State required risk assessment. After the risk assessment is completed the committee will schedule a meeting to review the draft report.

Budget:

Mr. Devincenzi reported that the Board received a copy of the roll-over budget that currently reflects a 3.14% increase. He indicated that some areas that still need to be explored are BOCES costs, teacher retirements, health insurance, special education inclusion class sizes, elementary class sizes and an analysis of State Aid. The District received notification that the CPI that will be used in the tax cap formula will be 2%. The goal is to maintain and enhance programs. Like the past five years, the District anticipates being within the tax cap and will utilize fund balance and reserves to offset expenses. The projected tax levy limit will be submitted by March 1st to the State Comptroller.

Buildings & Grounds:

Mr. Frisbie reported that the Buildings and Grounds Committee met on January 10, 2018. The committee reviewed and discussed the potential for establishing a capital reserve. The purpose of the reserve would be to pay for future capital project work in order to limit and/or eliminate borrowing to pay for these projects. A recommendation to approve the reserve will be presented to the Board on the March Agenda. If approved by the Board, the establishment of the capital reserve would be a separate proposition on the May Budget Vote Ballot. Mr. Frisbie also noted that on the January 18th Board agenda is the recommendation to approve the contract for electric supply with Direct Energy Business. Phase II work on the well is being completed and work on the press box and bleachers is scheduled to resume in March 2018.

CDEP:

Mr. O'Mara reported that the CDEP Committee has not met since the last Board meeting. The next committee meeting is scheduled for February 7, 2018, at 9:00 a.m., in the High School Auditorium.

Curriculum/TAG:

Mrs. Anderson reported that the Curriculum/TAG Committee met on January 9, 2018. Mrs. Herrington reviewed the District's 2016-17 school report card and spoke about the grades 3-8 ELA, Math, and Science accountability ratings and presented the secondary accountability ratings. In addition, she discussed the new accountability system in the Every Student Succeeds Act Plan. The committee discussed the pre-requisites for the High School Mandarin course for the 2018-19 school year, which now requires the completion of Spanish 3 rather than Spanish 4. Mrs. Herrington also presented an update on the High School Capstone Course. Mrs. Werlau, TAG Coordinator, spoke about the TAG programs that have been scheduled throughout the school year. The Lego Team will compete on Saturday, January 27, 2018, from 9:45 a.m. to 2:45 p.m. at Sandfordville Elementary School located in Warwick. The Odyssey of the Mind Team will be competing on Saturday, March 10, 2018 at Orange Ulster BOCES, time to be determined. The next meeting is scheduled for March 6, 2018, at 6:30 p.m., in the high school library.

Health & Safety:

Mr. Missale reported that the Health & Safety Committee met on January 10, 2018. Building safety teams continue to meet on a monthly basis to review the drills that have been performed and the procedures within the buildings. At the meetings, feedback was provided regarding the drills that have been performed. The buildings will begin to complete their required second semester emergency drills in the near future. The next meeting is scheduled for April 5, 2018, at 3:45 p.m., in District Office.

Legislative:

Mr. Petroccelli reported The Ulster County School Board Association meeting is scheduled on January 25, 2018, at Ulster BOCES with our legislators. He also indicated that Governor Cuomo released the 2018-2019 State Budget and proposed a \$769 million increase in State Aid and \$338 million increase in Foundation Aid (1.5 % increase). Mr. Castle indicated that he and Mr. Devincenzi met with Assemblyman Brian Miller on January 18th; focal points of discussion included topics such as State Aid, Foundation Aid, the flexibility to establish reserves (i.e. TRS) and the tax levy cap. Additional meetings are scheduled with Senator Bonacic, Senator Larkin and Assemblyman Cahill.

Policy:

Mr. O'Mara reported that the Policy Committee has not met since the last Board meeting. There are three policies for second reading on the January 18th Board agenda. The next committee meeting is scheduled for February 6, 2018, at 6:30 p.m., in District Office.

Technology:

Mr. Spencer reported that the Technology Committee has not met since the last Board meeting. The next committee meeting is scheduled for January 22, 2018, at 3:30 p.m., in the high school library.

Wellness:

Mr. Spencer reported that the Wellness Committee met on January 9, 2018. At the meeting, Amy Bishopp discussed upcoming events such as guest chefs throughout the District, a noodle bar at the high school on January 30th and a taste test scheduled on January 19, 2018, at the Clare F. Ostrander Elementary School. Leptondale is going to start their "Taste Test Tuesday's" again for kindergarten students in order to expose them to new foods. February 2nd will be Wear Red for American Heart Association Awareness Day and all schools were encouraged to participate. In addition, all the elementary schools will be participating in Jump Rope for Heart in February. There was a blood drive scheduled for January 17th at the high school, but due to a snow day will be rescheduled. The Health Fair at the high school is scheduled for April 24th. The next committee meeting is scheduled for April 16, 2018, at 3:30 p.m., in the high school library.

Student Rep:

- The Nordic Ski Team has had 3 meets so far with their first home meet on January 18th against New Paltz and Monticello.
