### 4. Approve Minutes – [3/16/17 Regular Board Meeting] – Agenda #4

Mr. O'Mara moved the Board accept the recommendation of the Superintendent and approve the minutes of the March 16, 2017, Regular Board of Education Meeting.

#### 5. Board Committee Reports

#### Audit:

Mrs. Crowley reported that the Audit Committee met on March 27, 2017, to review the Internal Risk Assessment Report; a copy was handed out to the Board. The next committee meeting is tentatively scheduled for May 30, 2017, at 6:30 p.m., in District Office with external auditors, Nugent and Haeussler to review the external audit scheduled for this summer.

## Budget:

Mr. Devincenzi reported that the recommendation to approve the 2017-2018 Proposed Budget, District Budget Notice and Property Tax Report Card is on the April 19, 2017 agenda. The proposed tax levy increase is 1.99% (within the cap) and the overall budget increase is 2.47%. The proposed budget allows the District to maintain programs and extra-curricular activities. In addition, the proposed budget includes the addition of a Modified Boys Lacrosse Team, Girls Swim Team (will swim at a neutral site) and a Girls Lacrosse Club. PTO/PTA budget presentations are all scheduled for 7:00 p.m., and will be held on May 2, 2017 at Ostrander Elementary School, May 3, 2017, at Leptondale Elementary School and May 8, 2017 at Plattekill Elementary School. The Public Budget Hearing will be on May 4, 2017, at 7:00 p.m., in the high school library. The annual budget vote is May 16, 2017, from noon to 9:00 p.m. at the Leptondale Elementary School, Plattekill Elementary School and Senior High School. Budget documents will be made available on the website.

#### Buildings & Grounds:

Mr. Frisbie reported that the Buildings and Grounds Committee met on April 27, 2017, to discuss the progress of Phase I of the Capital Project and future Phase II improvements such as the press box, doors and padding in the gymnasiums. The recommendations to approve the amended agreement with Landscape Unlimited, Inc. and award the fence replacement contract are on the April 19, 2017 agenda. In addition, there was a building walk-through on April 19, 2017, at the Leptondale Elementary School. Mr. Castle reported that the Board will be sending a letter to legislators regarding the construction of the Pilgrim Pipeline.

### CDEP:

Mr. O'Mara reported that the CDEP Committee met on March 22, 2017. Mrs. Herrington presented an update on the District's technology updates. Building teams reviewed their 2017-2018 SIT Plans in preparation for the April 5, 2017 meeting with the Board of Education. At the meeting on April 5<sup>th</sup>, CDEP building teams presented their finalized 2017-2018 SIT Plans to the Board of Education. CDEP Committee meetings have concluded for the 2016-2017 school year, and will resume in the fall of 2017.

## Curriculum/TAG:

Mrs. Anderson reported that the Curriculum Committee has not met since the last Board of Education meeting. The final meeting will take place on April 25, 2017, at 7:00 p.m. in the High School Library.

#### Health & Safety:

Mr. Missale reported that the Health & Safety Committee has not met since the last Board meeting. The next committee meeting will take place on April 20, 2017, at 3:45 p.m., in District Office.

#### Legislative:

Mr. Castle reported that the State Budget did not pass on time, but was passed during Spring Recess and provided the District an additional \$200,000 more than what the Governor projected in January. This has allowed the District to remain within the tax cap and maintain and enhance programs in the District. In addition, the average K-12 class size will remain at approximately 20 students, which will be beneficial to students as the District rolls out new technology into the classrooms.

### Policy:

Mr. O'Mara reported that the Policy Committee met on April 6, 2017. The next meeting is scheduled for May 4, 2017, at 6:30 p.m. in the High School Library.

#### Technology:

Mr. Spencer reported that the Technology Committee did not meet since the last Board meeting. The final meeting of the Technology Committee for the 2016-2017 school year will take place on April 24, 2017, at 3:30 p.m. in the High School Library.

### Wellness:

Mr. Spencer reported that the Wellness Committee met on March 30, 2017, with a representative who is helping to prepare the Food Service RFP. Feedback was provided to include more heathy choices into the menu. Starting in the 2017-2018 school year, chocolate milk will no longer be served for breakfast at the elementary schools. Mr. Devincenzi reported that the Food Service RFP bid specs are currently being reviewed by the State, a notice for the RFP will be in the paper on May 10, 2017, the bidder conference will take place on May 18, 2017, and the bid opening will be on June 7, 2017.

## Student Rep:

Michael Cappuccilli reported the following:

- With fourth quarter beginning, students are preparing for their AP exams which will be taking place in the near future.
- The annual college fair is on April 27th. This year the high school guidance department has invited 70 colleges to attend and to answer questions by students who are looking to pursue the college path.
- The Health Fair is on April 26th, which helps to promote the importance of staying healthy. It includes a hands-on "Battle of the Belts" competition for students to participate in, which allows for a fun, but knowledgeable experience.
- Junior Prom is on April 28th and for the fourth year in a row will be held at Eisenhower Hall in West Point.
- On April 24th, a "Not One More" forum will take place in the high school auditorium and will include a panel of knowledgeable guest speakers who have first-hand experience in dealing with teen reckless driving.
- The Senior Class departs for their class trip to Florida on April 21st and returns April 24th.
- The high school band and choir traveled to Virginia over Spring Recess and proudly represented Wallkill in a music competition by showing off their flawless skills by taking the titles "Best Orchestra" and "Best Overall Mixed Choir".
- A representative from the Ulster County Board of Elections will be visiting the high school to register students to vote who are 18 years of age and older.
