7.C. Approve Appointments – Instructional

The Board accept the recommendation of the Superintendent and approve the appointment of **Karen Kramer-Ley** to a Permanent Per Diem Substitute Teacher position, assigned to the Senior High School for the 2018-2019 school at a rate of \$107.00 per day, effective December 21, 2018.

The Board accept the recommendation of the Superintendent and approve the appointment of **Margo Tucker** certified as a Family and Consumer Sciences Teacher, to a three-year probationary period in the tenure area of Home Economics commencing February 1, 2019 and ending January 31, 2022. To the extent applicable under Education Law Section 3012-d and the accompanying Commissioner's Regulations, in order to be considered for tenure, Ms. Tucker must have received an APPR rating of effective or highly effective in three of the four preceding years and must not receive an ineffective in the final year of the probationary period. Effective February 1, 2019, Ms. Tucker's salary will be \$53,386 pro-rated (1NMA + 0 credits). Ms. Tucker replaces Lori Hughes who has retired.
